## Are you having difficulty breastfeeding due to ???

- Sore nipples
- Breast engorgement
- Infant having difficulty latching-on or difficulty feeding at breast
- Infant with genetic, neurologic, mechanical or other infant issues
- Premature, late preterm or multiples
- Ill or hospitalized breastfeeding infant or mother
- Mother or infant with special needs
- Concerns related to medications in mother's milk
- Need to supplement for low milk supply or infant's slow weight gain
- Very low milk supply and need to increase your milk production
- Other disorders or complications of lactation
- Need to return to school or work

## To Qualify:

1. You must have delivered your new baby and be breastfeeding or feeding breast-milk to your baby
2. You must be enrolled in:  
**Ohio Medicaid** or  
  
one of the  
Ohio Medicaid Managed Care Plans:
  - **Buckeye** Community Health Plan
  - **CareSource**
  - **Molina** Healthcare of Ohio
  - **Unison** Health Plan
  - **Amerigroup**
4. You must have a **prescription showing your medical need** for a breast pump written by one of the following:
  - Physician
  - Advanced Practice Nurse
  - Certified Nurse Midwife
  - Physician Assistant

(For further information, HCPs may refer to Ohio Medicaid Code for medical necessity – 5103:3-1-01)

*Qualifying mothers can expect to have their pumps shipped within 24 hours of registration*

## To Receive your Pump:

1. Contact a Lactation Consultant for advice and assistance with breastfeeding difficulty.
2. Contact Mothering Touch at  
**419-525-4620**  
to register for a breast pump  
  
then...
3. Ask your doctor's office to fax a prescription for an  
"electric breast pump."

(RX must include mother's name and her medical diagnosis, which shows her medical need for a breast pump)

***\*\*The prescription must be written in the mother's name (not the baby's) and should include a medical diagnosis for the mother, i.e. "Breastfeeding Difficulty," "Low Milk Supply," "Sore Nipples," etc.***
